Notice at Collection for California Residents

Effective Date: March 13, 2024

1. INTRODUCTION

This Notice at Collection for California Residents (the "**California Notice at Collection**") describes the actual or potential collection and use of Personal Information by Recurrent Energy (including Recurrent Energy B.V. and each of its applicable subsidiaries, the "**Company**"). This California Notice at Collection applies solely to all visitors, users, and others who reside in the State of California ("**Consumers**" or "**you**"). The Company is providing this notice in accordance with the California Privacy Rights Act of 2020, as amended ("**CPRA**") and any terms defined in the CPRA have the same meaning when used in this notice. To the extent that any terms of this notice are unclear, the Company will interpret them as required to comply with the CPRA.

2. SCOPE OF THIS CALIFORNIA NOTICE AT COLLECTION

The Company's "Platform" as used in this California Notice at Collection consists of the following:

- The Company's mobile applications, if any, that you download from the Apple App Store® or Google Play™ or similar store, together with any other similar mobile applications;
- The Company's devices that connect to or interact with our Platform ("Devices"); and
- The Company's website(s) located at https://www.recurrentenergy.com.

This California Notice at Collection applies to information that we collect when you use the Company's Platform that identifies, relates to, describes, references, is capable of being associated with, or could reasonably be linked, directly or indirectly, with you or your device ("**Personal Information**"). However, publicly available information that the Company collects from government records and deidentified or aggregated information (when de-identified or aggregated as described in the CPRA) are not considered Personal Information and this California Privacy Addendum does not apply to such information.

This California Notice at Collection does not apply to employment-related Personal Information collected from our California-based employees, job applicants, contractors, or similar individuals ("**Personnel**"). Please contact your local human resources department if you are part of our California Personnel and would like additional information about how we process your Personal Information.

This California Notice at Collection also does not apply to Personal Information reflecting a written or verbal business-to-business communication ("**B2B Personal Information**"). Please see our California Privacy Addendum for B2B Personal Information for information regarding our practices regarding your B2B Personal Information.

4. PURPOSES FOR COLLECTING AND SELLING/SHARING OF YOUR PERSONAL INFORMATION

The Company may collect your Personal Information to support its business operations, including for the following purposes that apply to all of the categories of Personal Information described above:

- Provide our Platform and related Services;
- Security and legal purposes;
- Carry out our legal and contractual obligations, and enforce our rights arising from any contracts entered into between you or your affiliates and us, including for billing and collection.
- To respond to law enforcement requests, court orders, and subpoenas and to carry out our legal and contractual obligations.
- Conduct business development, marketing and sales activities (including, for example, generating leads, pursuing marketing prospects, performing market research, determining and managing the effectiveness of our advertising and marketing campaigns and managing our brand)
- Authenticate use, detect fraudulent use, and otherwise maintain the security of our Platform and the safety of others.
- To notify you about changes to our websites or any products or services we offer.
- To administer surveys and questionnaires.

- To provide you information about products and services that may be of interest to you, including through newsletters.
- Any other purpose with your consent.

The Company will not sell any category of Personal Information (including Sensitive Personal Information) it collects for monetary or other valuable consideration. The Company also will not share it with third parties for cross-context behavioral advertising. The Company only uses or discloses your Sensitive Personal Information as necessary to provide you with access and use of our Platform and as described above and for no other purposes.

5. PERSONAL INFORMATION RETENTION PERIODS

The Company may retain each category of Personal Information described above for as long as you access and use the Platform (which includes for as long as one of your Devices communicates with the Platform) and for a period of 1 year thereafter. However, the Company may also retain any or all categories of Personal Information when your information is subject to one of the following exceptions:

- When stored in our backup and disaster recovery systems. Your Personal Information will be deleted when the backup media your Personal Information is stored on expires or when our disaster recovery systems are updated.
- When necessary for us to exercise or defend legal claims.
- When necessary to pursue, enforce or comply with a legal obligation.
- When necessary to help ensure the security and integrity of our Website and IT systems.

Your Personal Information will be deleted when we no longer require your Personal Information for any of the above purposes.

6. CHANGES TO THIS CALIFORNIA NOTICE AT COLLECTION

The Company reserves the right to amend this California Notice at Collection at its discretion and at any time. When the Company makes changes to this California Notice at Collection, it will provide an updated notice before collecting any additional personal information. Your continued provision of personal information following the posting of changes constitutes your acceptance of such changes.
